### Item 1 James Lane, New Plymouth

- Revoke No-Stopping on the east side of James Lane from 4.3m to 14.3m (10.0m) measured in a northerly direction from the prolongation of the north kerb of Devon Street West.
- Revoke the Loading Zone (P5, goods vehicles only) on the east side of James Lane from 14.3m to 24.3m (10.0m) measured in a northerly direction from the prolongation of the north kerb of Devon Street West.
- Revoke No-Stopping on the east side of James Lane from 24.3m to 57.5m (33.2m) measured in a northerly direction from the prolongation of the north kerb of Devon Street West.
- Revoke No-Stopping on the west side of James Lane from 4.3m to 54.4m (58.7m) measured in a northerly direction from the prolongation of the north kerb of Devon Street West.
- Create a Loading Zone (P5, goods vehicles only) on the east side of James Lane from 51.5m to 57.5m (6.0m) measured in a northerly direction from the prolongation of the north kerb of Devon Street West.
