EXECUTIVE SUMMARY

This report recommends receipt of the annual report on proceedings and operations of the District Licensing Committee (DLC) as required under Section 199 of the Sale and Supply of Alcohol Act 2012. A copy of the annual report must be made available free of charge, and on the internet site. The Act requires Council to send the annual report to the licensing authority (Alcohol Regulatory and Licensing Authority-ARLA).

BACKGROUND

The Sale and Supply of Alcohol Act 2012 requires the Council to prepare and send to the licensing authority a report on the proceedings and operations of its licensing committee during the year.

Section 199 Annual report

- *(1) Within 3 months after the end of every financial year, every territorial authority must prepare and send to the licensing authority a report of the proceedings and operations of its licensing committees during the year.*
- (2) The licensing authority may specify the form of the annual report and the matters to be included in the report.*
- (3) The licensing authority or the licensing committee must, on payment of any reasonable fee it may prescribe, provide a copy of each report to any person who asks for one.*
- (4) Every annual report required to be prepared under this section is a public record for the purposes of this Act.*
- (5) A copy of every annual report must be made available by the territorial authority for inspection free of charge and be made available on an Internet site maintained by or on behalf of the territorial authority for a period of not less than 5 years.*

The details contained within the report (refer to Appendix one attached) meets the requirements of the Sale and Supply of Alcohol Act 2012, and is in the annual report format as recommended by the licensing authority.

SIGNIFICANCE

In accordance with the Council's Significance Policy, this matter has been assessed as being of some importance although this will be of interest to all sectors of the community.

OPTIONS

Option 1 The report is required by section 199 of the Sale and Supply of Alcohol Act 2012. Acceptance of the report and forwarding it to the licensing authority is the only practicable option in this case.

Recommended Option

This report recommends option 1 for addressing the matter.

REPORT TO THE ALCOHOL AND REGULATORY LICENSING AUTHORITY

FOR PERIOD 1 JULY 2013 TO 30 JUNE 2014

PURPOSE

Section 199 of the Sale and Supply of Alcohol Act 2012 requires a report to be submitted from the District Licensing Committee (DLC) to the Alcohol Regulatory and Licensing Authority (ARLA) covering the period ending 30th June 2014.

OVERVIEW OF THE DISTRICT LICENSING COMMITTEE WORKLOAD

In forming the District Licensing Committee (DLC) for the New Plymouth District, the New Plymouth District Council and neighboring Stratford District Council engaged in discussion in forming a shared list of committee members for their respective committees. Later in 2013 the list of members was finalised, approved and publically notified by both Councils. The New Plymouth District Council has appointed a Commissioner Alex Matheson and Cr Craig McFarlane is the Deputy Chairperson appointed in the absence of the Commissioner.

The change over from the District Licensing Agency to the District Licensing Committee has lead to considerable changes in light of the processes having to be implemented under the Sale and Supply of Alcohol Act 2012, particularly updating the computer software, and the administration component.

The District Licensing Committee has been busy reviewing and approving uncontested applications throughout the year. As most applications have been unopposed these have been considered by the Commissioner or Deputy Chairperson. The Committee has heard two contested applications for special licences. One application was refused and the other granted with conditions imposed.

Supporting the DLC team, the Environmental Health team comprises of a Chief Licensing Inspector, a Senior Licensing Inspector, and four Environmental Health Officers who are also appointed as Licensing Inspectors.

TRAINING

In conjunction with the Stratford District Council three extensive workshops were provided for DLC members that overviewed guidelines, responsibilities, expectations and the Sale and Supply of Alcohol Act 2012.

Two Licensing Inspectors attended the New Zealand Institute of Liquor Licensing Inspectors conference at Taupo in September 2013. The major focus was on the Sale and Supply of Alcohol Act 2012 and the impact and obligations to Territorial Authorities.

All Inspectors attended the National Regulatory Agencies Steering Group CollaborAction Workshops. These workshops covered the introduction, enforcement and monitoring under the Sale and Supply of Alcohol Act 2012.

LOCAL ALCOHOL POLICY

The New Plymouth District Council in conjunction with Stratford District Council developed a combined draft Local Alcohol Policy that was approved by both councils and put out for public consultation in March 2014. A total of 103 submissions were received on the draft policy, of which 15 submissions are related to Stratford's policy content.

In summary the provisions of the draft policy are restrictions on where licensed premises can be located, restrictions on the number of new off licensed premises and maximum trading hours for both on licensed and off-licensed premises. A range of non-mandatory discretionary licence conditions, including a One Way Door Policy were proposed. Key themes that emerged throughout the submissions were the need for the LAP to minimise alcohol-related harm, the importance of ensuring communities, particularly vulnerable communities, are safe and that different types of licensed premises have different risks.

Hearings on the joint policy commenced in New Plymouth on 6 August 2014. Following these hearings, a provisional Local Alcohol Policy has been adopted and is now in the appeal period. Submissions close 28 November 2014.

CURRENT LEGISLATION TRENDS

With the enactment of the Sale and Supply of Alcohol (Fees) Regulations 2013, New Plymouth has noticed a trend in renewal applications for licensed premises with reduced hours to meet the lower fee criteria.

Some of the smaller clubs that previously operated under special licences throughout the year have opted not to sell alcohol as they have found it financially difficult to apply for a special licence under the Sale and Supply of Alcohol Act 2012.

MANNER OF PUBLIC NOTICE OF APPLICATION

The DLC raises concerns about the requirement of the Sale and Supply of Alcohol Regulations 2013 which requires an application to be published in a newspaper circulating in this district **or** on the internet site. With most applicants choosing the internet site for advertising the DLC has received concerns from some community members who have been unaware of the application (i.e they do not access the internet site on a regular basis). The DLC recommends that it should be a mandatory requirement to provide a publication in both the newspaper and the internet site. It is acknowledged that a notice is placed on the building by the applicant.

INITIATIVES

Over the 2103/2014 period the Senior Licensing Inspector has held Liquor Liaison Group meetings with all licensed premises and the Agencies. These meetings received great attendance by licensees, managers and bar staff. This gave all parties an avenue to discuss legislation changes, any queries, feedback and generally what was happening in the New Plymouth District.

The drinksafe workshops were held in November and were well attended by barstaff, licensees and managers.

A combined Agency Agreement (CAA) has been drafted and is in the process of being approved. The CAA gives a clear understanding of the collaboration between the agencies (Police, Medical Officer of Health and Licensing Inspector).

The Alcohol Accord continues to aim to improve safety and perception of safety in the Central Business District (CBD) through working collaboratively with licensee responsibilities under the Sale and Supply of Alcohol Act 2012. The group still continues with the Mellow Yellow project aiming at a co-ordinated response between licensees and police in responding to crime and or violence in the CBD, and early identification of problem customers and actions taken between stakeholders in controlling possible escalation of alcohol related harm.

The Senior Licensing Inspector continues to assist with training at the Western Institute of Technology Taranaki (WITT) and other training providers for the Licence Controller Qualification courses with prospective managers. This is a valuable opportunity to pass on our expectations of managers in licensed premises.

Licensing Inspectors continue to interview all new manager applicants as we see it as a critical component for assessing the suitability of managers entering the hospitality industry.

The 24 hour seven days a week Liquor Ban in the New Plymouth CBD continues to be effective and the Police find it to be a valuable tool together with the CBD Cameras to

deal with liquor related problems before they get out of hand. In addition a liquor ban is imposed along a portion of the coastal walkway area (Mt Bryan – Fitzroy) during the period of 1 November to 1 April each year during the hours of 2.00pm and 7.00am the following day from Thursday evening to Sunday morning and on Christmas Eve and New Years Eve.

The Inspectors have conducted late night inspections of licensed premises. Operations have visited premises for such things, selling to minors, drinking in non licensed areas, the signing in of visitors and the use of Specials for private functions. On and Off Licences have been subjected to overt and covert operations instigated by the agencies checking compliance with conditions of licence and breaches of the SSAA generally.

Major events including WOMAD and international acts at the Bowl of Brooklands operating under Special Licences were inspected a number of times throughout the events. Overall the events were responsibly well managed.
